## World Wetlands Day 2015 celebrated

he World Wetlands Day 2015 was celebrated on 2<sup>nd</sup> February 2015 at Atebwo primary school, Nandi County. The event was geared towards creating awareness on wetlands conservation as well as commemorating the day the Ramsar Convention was entered.

The celebrations started earlier with a courtesy call to the Nandi County commissioner, Matilda Sakwa and H.E governor Cleophas Lagat who briefed the guests led by NEMA chair, Maluki Mwendwa, NEMA DG Prof. Geoffrey Wahungu, KWS DG Mr. William Kiprono, WRMA board Chair, Mr. Peter Kiilu, Nandi County executives, MCAs among other high profile guests who flanked their leaders.

The convoy of cars then proceeded to Atebwo primary school where the public had already gathered waiting for the dignitaries to arrive for commencement of the event. The procession to the Kibirong wetland was then flagged off by the governor.

The much awaited celebrations had been preceded by two build up events; the Kibirong community road race marathon and a panel discussion in Siaya on Yala Swamp. There was also a tree planting session as well as exhibitions by the stakeholders such as NEMA, WRMA, KWS, and KFS among others.

"As the lead agency in matters of environment, NEMA continues to work hand in hand with all the stakeholders to ensure wetlands and the environment in general remains a priority for the Authority" the DG said.

part of NEMA's commitment to As conserve the wetlands and resources, the Authority among many other things has: guided development of integrated management plans for various wetland ecosystems in the country; inventoried wetlands across the country to enhance monitoring and tracking of ecological changes in the wetlands; participated in the wetlands mapping exercise and developed Kenya's first wetlands and continuously undertaken monitoring of wetlands to ensure wise use and curb any practices on wetlands that may result in degradation and over exploitation of these ecosystems

Nandi County Governor H.E Dr. Cleophas Lagat expressed his concern over the state of wetlands in Kenya. "Management of wetlands requires a collaborative effort," he added. He stated that wetlands and forests have continually been degraded despite efforts by government agencies to safeguard them.

He was grateful that NEMA had seen it important to celebrate this year's World

Wetlands Day in his county. government recognizes that wetlands are kidnevs the earth's through hydrological and chemical functions and are a key resource in promoting the County socio-economic development," the governor said. He added that the commemoration of the event was a platform through which public awareness should be raised about the values and benefits of wetlands as well as sustainable development and wise use of wetlands. He urged the public to work together with the government to secure our environment and mitigate against climate change.

Speaking during the event, NEMA board chair, Mr. Maluki Mwendwa stated that the year 2015 provides a platform for the United Nations International Year of transition from the Millennium Development Goals to Sustainable Development Goals.

The WWD 2015 theme highlights the need for sustainable management of wetlands for the present and future generations which is in line with our pursuit of Kenya Vision 2030. He added, "We must monitor and stop the negative implications which may result from our activities. These are issues such as overfishing, excessive hunting of birds and animals, over abstraction of water, pollution due to excessive fertilizers and reclamation or complete drainage of wetlands. All these could emerge as outcomes due to an excessive load on wetlands therefore completely destroying them".

Essentially, the conservation of wetlands is pivotal if at all we are to safeguard our future. "Nandi County is endowed with many wetlands comprising of rivers, lakes, swamps, dams and springs among others contributing immensely to the socioeconomic and ecological development. Despite the myriad of functions performed by wetlands, the threats faced by these are due to inadequate information and lack of recognition of the values that wetlands plav towards achieving a sustainable environment", Maluki said.

The chair reiterated that NEMA recently developed a five year integrated management plan for Kibirong Wetland Ecosystem that seeks to reverse the degradative actions that have impeded the sustainable management and utilization of this once bountiful ecosystem. This Management Plan aims at promoting conservation and sustainable utilization of the Wetland resources within the Ramsar Convention's Wise-use Principle.

There is also the need to work with Counties to restore and rehabilitate wetlands to curb threats resulting from human activities.

#### **World Wetlands Panel Discussion Held**

he World Wetlands panel discussion was held on 27th January, 2015 at the Agriculture Training Centre (ATC) in Siaya County. This was the second build up activity for WWD 2015, dubbed Balancing Conservation and development: the case of Yala swamp. The aim was to raise awareness, and build capacity on how to strike a balance between human development and biodiversity conservation.

The Yala Swamp wetland was recently accorded reserve status and is one of the few remaining extensive freshwater wetlands in Kenya. The challenges and threats facing the swamp includes; overexploitation of wetland (natural) resources. vala swamp drainage, reclamation and conversion, Environmental Degradation and public health issues, among others.

The Panelists were: Prof. Geoffrey Wahungu, Director General, NEMA: Mrs. Sarah Ondego, CEC, Environment, Water and Natural, Resources Siava County; Dr. Romulus Abila, Southern Eastern Kenya University (SEKU); Dr. Paul Mworia, Nature Kenya; Mr. Elijah Obadha, Yala Wetland Environmental volunteer: Mr. Alfred Otieno, Seje Safe Water, Siaya County; Ms. Faith Lelei, Dominion Farms Ltd. Yala Swamp; Mr. Sabuni Wanyonyi, Regional Manager, LVSWCA and Mr. Maurice Ogoma, Ecofinder Kenya.

Also in attendance were the Chief Officers from the County, in charge of Environment and Tourism among other stakeholders. At the end of the discussion participants were able to put into context and dissect economics of yala swamp, how they can manage and sustain a green and climatesmart investiment, as well as financial mechanisms or incentives for Biodiversity conservation for the important and highly vulnerable and threatened Yala swamp.

In his closing remarks, the Director General Prof. Wahungu, thanked Mr. Ramburu who was the panel discussion moderator, for guiding the participants all through the session, the Siaya County Government for their genuine interest and support, the panelists for their contribution, and the participants. He said that NEMA will work with the County Government to save Yala.
